

**Offeror:** Buyer requests that Offeror complete this form to support Offeror's assertion that the goods or services (the "Item(s)") to be provided qualify as "Commercial Items" under Federal Acquisition Regulation (FAR) Subpart 2.1. Seller's failure to provide the information requested may preclude Buyer from accepting Offeror's assertion of commerciality, thereby requiring Offeror to provide substantial additional information to adequately support Buyer's potential acquisition of Offeror's Items if they are being procured in support of a U.S. Government prime contract.

- (1)  The Item(s) is (are) of a type customarily used for nongovernmental purposes and:

- (4)  The Item(s) represent(s) a combination of Items meeting the requirements of (1), (2) or (3), above, that are of a type customarily combined and sold in combination to the general public.

- (5)  If the Item(s) are services, said services are (i) installation services, or maintenance services, or repair services, or training services and other services; and (ii) such services are being procured in support of an Item or Items meeting the criteria of FAR Part 2.101 and the source of such services—
  - (a)  Offers such services to the general public and the Federal Government and its contractors contemporaneously and under similar terms and conditions; **and**
  - (b)  Offers to use the same workforce for providing the Federal Government with such services as the source uses for providing such services to the general public.
- (6)  If the Item(s) are services, said services are of a type offered and sold competitively in substantial quantities in the commercial marketplace based on established catalog or market prices for specific tasks performed under standard commercial terms and conditions.
- (7)  Any Item(s), combination of Item(s), or services referred to in (1) through (6) above notwithstanding the fact that the item, combination of items, or service is transferred between or among separate divisions, subsidiaries, or affiliates of the contractor.
- (8)  The Item(s) is (are) a non-developmental item as defined in FAR 2.101, which has been developed exclusively at private expense and sold in substantial quantities, on a competitive basis, to multiple State and local Governments.
